

# Changes to migration skills assessment

## ANMAC office shutdown

Our Skilled Migration Services team are introducing an online application system from 15 January 2018. The online application system will be introduced over our Christmas shutdown period from Friday, 22 December until Monday, 8 January 2018.

In preparation for the introduction of the online application system, ANMAC will not be accepting migration skills assessments from 12pm on Friday, 15 December 2017. Applications submitted up until 12pm on Friday, 15 December 2017 will remain paper-based, provide your correctly certified documents by mail. You will be able to apply for an online migration skills assessment from 9am on Monday, 15 January 2018.

## Online application system

From Monday 15 January 2018, all migration skills assessments must be provided to ANMAC using the online application system. The online application system is accessed on the ANMAC website. The system requires each applicant to create a login to access the online application forms and upload supporting documents.

The upload requirements for supporting documents are:

- Minimum 600dpi resolution
- Colour
- Original (certified documents will not be accepted)

Further information about ANMAC's supporting document requirements will be available on our website.

Prior to applying online, applicants must have requested registration verification from all relevant nursing jurisdictions to be sent directly to ANMAC. Your migration skills assessment cannot be finalised if ANMAC has not received this information. Please note, if you have Australian nursing registration you do not need to request this information.

The online application system allows ANMAC to email the 'Letter of Determination' to the applicant once the assessment has been completed. The Department of Immigration and Border Protection will also receive information related to the outcome of the skills assessments electronically.

## Modified PLUS assessment

ANMAC will be introducing a new assessment pathway on 15 January 2018. This assessment will enable applicants with a current 'Notice of in principle registration subject to proof of identity' from the Australian Health Practitioner Regulation Agency (AHPRA) to apply for a

migration skills assessment. Further details about the new assessment pathway will be available on the website.

## Fee structure

The online application system has enabled ANMAC to reduce migration skills assessments fees. The reduction in fees is effective from Monday, 15 January 2018
