The College believes that Standard 5.4 needs to include specific assessment in relation to prescribing via a structured prescribing arrangement. Eg 5.4 Assessment include the appraisal of competence in pharmacokinetics, pharmacodynamics, quality use of medicines and prescribing via a structured protocol.
