

Professional reference assessment

Applicants may be required to submit this form and payment if they require a professional reference assessment for ANZSCO code recognition, or to apply for extra points with the Department of Immigration and Border Protection.

All professional references MUST meet the criteria below. You will be required to provide professional reference(s) from employer(s) with evidence that you meet professional competencies in each position. The professional reference(s) must be able to identify the area of nursing/midwifery you were employed in, as per the ANZSCO code you nominate for each employer. Professional references dating back to ten (10) years can be assessed.

Each professional reference must come from your nurse/midwife manager (who **must** be a nurse/midwife) and **must** include **all** of the following:

- · Dates of employment
- · Areas of experience (use ANZSCO code)
- Statements and examples of your professional competence and safety as a nurse/midwife. Have specific day to day activities relevant to your area(s) of experience explained
- Comments on how you are observed to achieve competence and safety
- Date of the statement
- · Name, signature and position of the referee
- Printed on the organisation's official letterhead

Useful information:

- Registered nurses cannot have previous work experience as an enrolled nurse assessed for recognition of recency of practice, ANZSCO code recognition or points recognition
- Generic job descriptions cannot be accepted
- If dates of employment are not on your professional reference(s) you will
 need employment statements that detail the dates of employment as a nurse
 or midwife. This document should be requested from Human resources at the
 organisation
- ANMAC does not accept payslips in lieu of employment statements
- Please send correctly certified copies keep originals for your own records (we do not return documents at the completion of an assessment)
- · Failing to meet the above criteria will unnecessarily delay your assessment

ACCEPTABLE

A guide to help your referee prepare a professional reference for submission to ANMAC.

Reference to be provided on official letterhead

Must include contact details (address, telephone, email, website).

Date written

Address to ANMAC

Applicant's full name

Brief overview

- Must state that the applicant is employed as a nurse or midwife.
- Commencement date/dates of employment/full time part time capacity.

Body of reference

- Details of the ward/setting (not simply "Ward A")—make reference to ANZSCO code.
- Must provide details of nursing work undertaken in this setting.
- Examples of competence in carrying out nursing work.
- Brief comment on continuing professional development.
- Should be at least two paragraphs of detailed information.

Remember that ANMAC uses these professional references to make a recommendation to the Department of Immigration and Border Protection. They must be explicit and reflect your nursing/midwifery role accurately for ANMAC to make the correct decision.

Name, signature and position of the referee

Designation

Must be a nurse or midwife

What we CANNOT accept

- Employment that is less than three months full time equivalent.
- Payslips, generalised job descriptions, performance review documents.
- If claiming extra points for your visa we will not review;
 - less than one year (cumulative) work experience in Australia.
 - less than three years (cumulative) work experience internationally.
- references that relate to work experience over ten years ago.
